In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

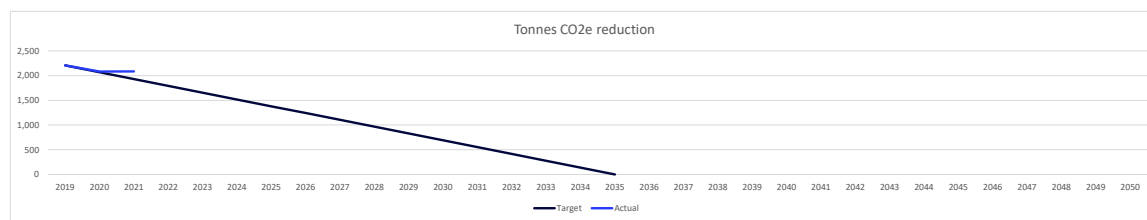

The following environmental management measures and projects have been completed or implemented since the 2019 baseline. The carbon emission reduction achieved by these schemes equate to a 6% reduction against the 2019 baseline and the measures will be in effect when performing the contract which is:-

- Move to virtual meetings using Microsoft Teams
- LED lighting
- Heating ventilation and air conditioning (HVAC) efficiency upgrades
- Energy reduction program – switch off policy, what runs, runs when needed only.
- Company car fleet transitioned to Hybrid vehicles
- Where work circumstances allow, employees given options for flexible working model to reduce accommodation requirements

In the future we hope to implement further measures such as:

- Migrate multi tenanted properties we occupy to 100% renewable electricity.
- Improve efficiencies in electricity consumption.
- Ongoing optimisation of building energy use and ensuring longer term strategies for building heating decarbonisation.
- **Improve data and reporting to improve accuracy of carbon accounting.**
- Reduce business travel emissions by disposing of company cars. Transport emissions will fall as cars, trains and planes produce less carbon.
- Engage with supply chain to ensure suppliers set carbon reduction targets and a commitment to net zero. Monitor top 200 supplier emissions annually.
- Reduce commuting emissions by encouraging home working and hybrid working.
